I hereby report that, during the Review Period:

a) Corporate Insolvency Resolution Process (CIRP) was initiated against the company YASHRAJ CONTAINEURS LIMITED vide order of NCLT Mumbai Bench dated 22-02-2024 under section 10 of the Insolvency and Bankruptcy Code, 2016 i.e. Initiation of Corporate Insolvency Resolution Process by the Corporate Debtor.

Thereafter Mr. Ajit Kumar has been appointed as a Resolution Professional and he has formed the committee of creditors within stipulated time period and all the other necessary compliances are under process.

- b) In terms of Regulation 6(1A) of the SEBI (LODR) Regulations, 2015, any vacancy in the office of the Compliance Officer is required to be filled at the earliest and in any case not later than three months from the date of such vacancy. However, Yashraj Containeurs Limited appointed Mr. Uday Anant Sawant as the Company Secretary and Compliance Officer only on 10/05/2024. Prior to this appointment, there was no Company Secretary or Compliance Officer in place, resulting in non-compliance with the prescribed time limit under the said regulation.
