### SUMMARY OF PROCEEDINGS OF 31<sup>st</sup> AGM of Yashraj Containeurs Ltd.

The 31<sup>st</sup> Annual General Meeting (AGM) of the Members of the Company was held on Thursday, September 26, 2024 at 12.30 p.m. (IST) through Video Conference (VC) / Other Audio Visual Means (OAVM) in the presence of Resolution Professional. Mr. Jayesh Valia Whole Time Director of the Company, chaired the proceedings of the Meeting.

The number of shareholders as on record date June 21, 2024, were 6522.

The Chairman called the meeting to order as requisite quorum was present. He welcomed all Board members, shareholders and invitees to the meeting. He briefed about current status of the company while addressing to the shareholders.

The Chairman then informed the Members that the Report of Board of Directors and the Accounts for the Financial Year ended 31<sup>st</sup> March, 2024 were taken as read as the same had already been circulated to the Members.
